

Ιδιωτικοποίηση Ουκρανικής Κρατικής Εταιρείας

Το Εμπορικό και Βιομηχανικό Επιμελητήριο Αθηνών (Ε.Β.Ε.Α.) ενημερώνει τις επιχειρήσεις – μέλη του και κάθε ενδιαφερόμενο ότι το Ταμείο Κρατικής Ιδιοκτησίας της Ουκρανίας γνωστοποίησε την ιδιωτικοποίηση της κρατικής εταιρείας αλκοολούχων ποτών “UKRSPYRT”.

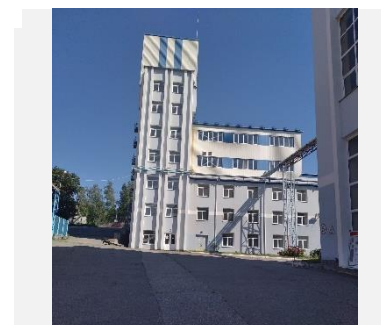
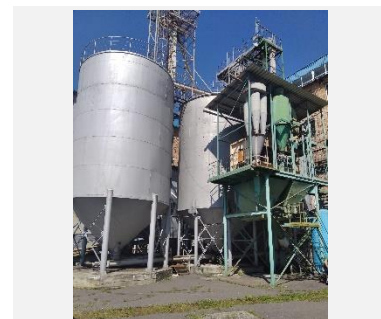

Privatization conditions

- keeping the types of activities that were carried out by this facility of "UKRSPYRT" state-owned enterprise, namely: the production of rectified ethyl alcohol, until July 1st, 2021;
- keeping until July 1st, 2021 on the production not less than 70% of personnel positions involved in production as of January 1st, 2020, and employment there for 2 months of at least 84 people;
- maintaining the civil protection equipment in proper condition for 2 years (part 8 of Article 32 of the Civil Protection Code).
