**“PRODUCTION COMPLEX “POLTAVA LOCOMOTIVE
REBUILDER” LLC offers a joint venture project in deep grain
processing and food production.**

The Ukrainian side offers cooperation on joint projects in grain processing and food production. For these purposes, we offer two objects of private property:

1. A plant and an area of 33 hectares in Poltava region with a powerful infrastructure to accommodate the line for deep processing of grain. The share for the Investor in the object is being discussed.

A medium pressure gas pipeline DN 250 mm is laid to the said area. The gas transmission system is connected to the system of JSC “Poltavagas” through a metal gas pipeline DU 80 mm with subsequent fixing of gas consumption by a rotary measuring complex KVR-1.01-P250-80-0.9-1.6 with fixing Q min – 1.6 cubic meters per hour and Q max – 400 cubic meters per hour.

The area is connected to electricity. Cell No. 33 RU-6 kW (Vm-630A). Electricity is supplied via cable 2 ASB – 3*240 with a length of 570 m, allowable power of 3800 kW. Connected load is 12440.0 kW.

There are also two artesian wells for beverage production. Well No. 1: depth – 363 m, pipe length 115 m in diameter, submersible pump capacity – ESV-10-150 is 63 cubic meters per hour, power – 45 kW.

Well No. 2 – depth 365 m, pipe depth – 115 m, pipe diameter – 110 mm, pipe diameter – 100 mm, submersible pump capacity – ESV-10-150 is 63 cubic meters per hour, power – 45 kW.

An approach line 2274 m long, railroad bed size P50 is directly connected to the area. Connection of Poltava-Pivdenna railroad tracks.

The Ukrainian side is ready to present the areas, engineering and working staff, perform all types of work, management, and ensure grain supply 250,000 tonnes per year for full capacity utilization.

We expect from potential partners readiness to participate in the project, in particular:

- Decision on joint activities;
- Investment in the project (about EUR 250-300 million);

- Typical project of the plant with a capacity of 250,000 tonnes per year, cash flow of the project, business plan, providing a full set of equipment;
 - Training of our specialists;
 - Installation and maintenance of equipment;
 - Organization of product sales.
2. The cost of the project also includes a logistics and industrial complex, with a separate area of 2.1 hectares (20,144.44 sq. m.), in downtown Kyiv, near the Central Railway Station, has 9,500 sq. m. of industrial premises, 4,000 sq. m. of office and domestic premises, as well as its own railway track of 430 meters, R-50. Connection of Kyiv – Tsentralnyi railroad tracks. Electricity: own transformer substation, two transformers 400 and 250 kVA. Water, sewerage works. The cost of the base on the investment part of the investor (60%) is EUR 12 million. Currently, all premises are leased and generate income as a business.
